Good Member Policy

<p>Summary:</p> <p>This Bulletin advises Kirra SLSC's position on the Good Member Policy.</p> <p>The Kirra Management Committee has endorsed the changes. The rules come into effect from the date of this bulletin.</p>			

Please be reminded that Kirra Surf Life Saving Club will be enforcing it's Good Member Policy. The club's Good Member Policy ensures that each club member is fulfilling both their patrolling and fundraising obligations on behalf of the club. In return for fulfilling the Good Member Policy criteria the club will provide coaching support and carnival entries. It is YOUR responsibility to ensure that you meet the club's Good Member Policy.

The conditions of the policy are outlined below:

- a) Entries to sanctioned carnivals which include Point Danger Branch, Queensland State, Ocean Roar series and the Aussie Title carnivals only.
- b) You must endeavour to make 100% of your rostered patrols. Records will be kept at the club. If you miss a patrol you will be required to do a makeup patrol. Any dispensation from this can only be given by the Club Captain for extenuating circumstances.
- c) All members and particularly members who plan to compete must attend the House to House House collections (Surf Appeal) or may contribute a cash donation of \$250 per Active member over 15 years of age per season or raise the amount through other means, or \$150 per Active member under 15 years of age and if more than one in the family a total payment or funds raised of \$250 per family per season.

- d) In the case of Nippers they must have attended 75% of Sunday Nippers. Nipper also pay \$5 per carnival towards carnival entry fees.
- e) In the case of Senior Competitors, the Surf Sports Officer and respective Coaches are required to confirm competitors training attendance for their discipline.
- f) Assist at, at least three club sanctioned events/activities for a minimum of 3 hours at each event/activity prior to the Queensland State Titles each season. Sanction events are set by the management committee at the beginning of the season. Examples maybe Cooly Classic Ocean Swims, Cooly Rock BBQ and Club hosted Carnivals.
- g) If a new member is joining or transferring to Kirra SLSC from other club for the first time, their obligations start from their joining date with Kirra SLSC.
- h) Members who transfer in/out/in to the club for competition reason, they are to still to compile with the Good Member Policy including at least 4 patrols at Kirra SLSC during that season.
- i) Payment of carnival entry fees are subject to the club available funds

A register of fundraisers will be kept in the Surf Club office. Any competitor who hasn't completed their club fundraising obligations will not have their entry fees paid for by the club for any of the remaining carnivals in the respective surf season.

** An exception to this rule is member from North Kirra who transfer to Kirra for competition reasons. These members are exempt as North Kirra SLCS contribute to the club for carnival entry expenses etc.
